#### **GERMAN CRIMINAL CODE - European Commission**

(2) German criminal law shall apply to other offences committed abroad if the act is a criminal offence at the locality of its commission or if that locality is not subject to any criminal law jurisdiction, and if the offender: 1 was German at the time of the offence or became German after the commission; or 2

#### **German Criminal Code (Strafgesetzbuch StGB)**

(1) German criminal law applies to offences committed abroad against a German national if the act is a criminal offence at the place of its commission or if that place is not subject to any criminal law jurisdiction (2) German criminal law applies to other offences committed abroad if the act is a criminal
